♪ Mission Statement

Tarrytown Dance strives to provide the best dance experience for dancers of all ages and all levels of experience in the Austin area.

♪ Classes

Classes are offered in Ballet, PrePointe, Tap, Jazz, Hip Hop, and Lyrical. Each class is approximately 1 hour in length (between 45 minutes and an hour and a half), and students are responsible for being punctual to class. Most classes are limited to 12 students, and some are limited to eight. If an appropriate class for your student is not available on the schedule, please call the studio at (512) 476-7715. Classes with fewer than 4 students may be cancelled.

♪ Spring Show

There will be a spring show held in mid-May 2010. All participation is voluntary; each performer will be required to pay a nominal recital fee.

♪ Tuition

All tuition is paid in advance for each semester and can be paid on-line at tarrytowndance.com. TUITION IS DUE IN FULL BY THE FIRST CLASS. If registration and tuition are not paid by the first month, your child will not be able to participate in class until payment is received in full. **Tarrytown Dance does not pro-rate for missed classes or late registrants.** There is a \$20.00 fee on all returned checks. The first semester will run from August 31 to December 19, 2008. The second semester will run from January 9 to May 14, 2009. The studio will not hold classes September 7th for Labor Day, November 24-28 (Thanksgiving), or March 13-19 (AISD scheduled Spring Break). For students who drop their class, a 50% refund will be granted for the remaining full months left in the semester. All class cancellations must be received in writing.

Class Policies

- Class changes and drops MUST be submitted to the office in writing.
- Tarrytown Dance reserves the right to cancel classes with low enrollment.
- Students are placed in class according to age and ability. Instructors have the right to move your child if they feel that another level is more appropriate.
- Missed classes may be made up by attending another comparable during the week. Instructor permission must be received before a make-up class may be attended.
- For our dancers' safety, students may not be dropped at the studio more than five minutes before class time and must be picked up promptly after class. Young dancers may not be left unattended at any time.
- Any student who is more than ten minutes late may be asked to sit and observe class by the instructor.
- All instructors reserve the right to ask a student who is disrupting class to leave.
- People watching in the lobby are not allowed to disrupt the instructor/class at any time unless there is an emergency.
- Please schedule meetings with instructors through the office. During and between class times instructors are not permitted to leave their classes unattended to speak to parents. It is best to meet privately when the instructor may spend adequate time discussing your questions/concerns.
- Absolutely no gum, food, or drinks are allowed in the dance rooms.

Dress Code

- Tarrytown Dance's dress code is strictly enforced.
- Hair must be secured away from face and off the neck.
- No jewelry is allowed to be worn during class (stud earrings are ok).
- All instructors reserve the right to ask a dancer to sit and observe class if they are not properly attired.
- Please do not allow your dancer to wear dance shoes outside of the studio.

BT Combo Class - Any color leotard, tights, petal skirt (please no tutus), pink ballet shoes, black tap shoes with elastic or Velcro closure.

Ballet - Black leotard, pink tights, petal skirt, pink ballet shoes

Lyrical - Any color leotard, booty shorts or Capri pants, tights, bare feet or lyrical sandal

Jazz/Latin Jazz/Leaps & Turns - leotard or dance tank with jazz pants or booty shorts, black jazz shoes; Latin Jazz class attendees may wear a short skirt to class.

Tap - leotard or dance tank with jazz pants, black tap shoes

Hip Hop - Capri, baggy, or cargo pants (absolutely NO shorts), t-shirt or tank, tennis shoes

Class Descriptions

BT Combo (Ballet/Tap) -- This combination class provides basic principles in ballet & tap to children ages 3 to 7. Dancers will learn ballet positions, ballet terminology, and elementary ballet movement such as plies, tendus, bourres and passes. Students will learn simple tap steps such as shuffles and shuffle ball change. BT Combo II is a class that moves faster than a regular ballet and tap class. This class is designed for the young dancer who learns quickly and has at least one year of experience.

Ballet -- TD offers a classical ballet program to students 5 years and older. Dancers will learn ballet technique through barre and center work. Combinations will become progressively more complicated as the dancer excels. Students who are ready for pointe work will be notified by the instructor.

Pre-Pointe - This class is to prepare the dedicated dancer for pointe work and is by invitation only. New students wishing to take this class will be evaluated by their instructor. Students are required to take at least one other ballet class in addition to the pre-pointe class, must be at least 10 years old and have had a minimum of one year experience in a level II class or higher.

Tap - Theater and Rhythm tap classes are offered to tappers of all ages and levels starting at 7 years old.

Jazz - TD offers a variety of jazz styles, from Jazz Funk to the unique style of Bob Fosse.

Hip Hop - An urban dance style involving quick, sharp moves and athletic-type stunts.

Lyrical - Lyrical dance combines the grace of ballet with the modern flair of jazz. It is known for its emotive fluidity and pairing with contemporary music. Lyrical students are required to have had at least two years of jazz class.

Leaps and Turns - This specialty class concentrates primarily on turning technique and improving turns such as pirouettes, attitude turns, fouettes, and turn combinations. The class will also focus on improving jumps and leaps including jetes, Russians, and switch leaps. Students are required to have had at least 2-3 years of jazz class.

Tarrytown Dance's Show Group Information

Tarrytown Dance offers two junior competitions team that compete annually in regional and national competitions. Each member is required to take a minimum of four hours weekly and is encouraged to take as many as ten hours weekly. Tarrytown Dance also hosts a performance team and a hip hop team that perform at community events and programs. All groups are comprised of girls, ages 9 to 11; teams are selected through an audition process and are required to take a special team class and attend weekend rehearsals.
